# *“What are the steps to adoption?”*

You make the choices in the adoption process. Decide when you want it to happen, who will adopt your baby, how things go while at the hospital, and if you want on-going contact after the adoption. It's never too late, even if you're already at the hospital or home with your baby. We're here for you anytime!

**1. Call or text Lifetime now: 1.800.923.6784.** You will speak with a caring adoption coordinator who can answer your questions and help start the process.

**2. Complete the basic information.** We can email or text you, or fax your hospital, with the forms to start the adoption process, and you can fill it out online or on paper.

**3. Look at families waiting to adopt.** Your coordinator will text or email you with links to families who are ready to adopt your baby. Each family has had background checks and will share ongoing contact with you after the adoption, if you'd like.

- Choose from adoptive parents of all races, from across the US.
- Speak to one or more families before deciding, if you wish.
- There are families for every situation, even if the baby was drug exposed or has special needs.
- The adoptive family you choose will travel to you, at a moment's notice. In most cases, the baby can be discharged from the hospital directly to the adoptive parents you've chosen, if you prefer.

**4. Sign the legal forms.** An attorney or social worker will meet with you when you are ready to sign the legal adoption papers. *All legal services are provided at no financial cost to you.*

**5. Get the support you need.** Counseling and support is available to you anytime. Your Lifetime coordinator is here for you, as long as you need her. And, after the adoption, you can continue to grow a relationship with your baby's adoptive parents, share updates together, and plan for your own future.
